FIELD DAY 2022

As you can see in the minutes of the May meeting it was decided to return to a in-person Field Day this year. We will again be setting up at Central Park in Whippany. The location is currently listed on the ARRL Field Day Locator. If you run Field Day from home please submit your score for the aggregate club score.

Here's a breakdown of the classes and other information.

(Class C) Mobile: Stations in vehicles capable of operating while in motion and normally operated in his manner. This includes maritime and aeronautical mobile. If the Class C station is being powered from a car battery or alternator, it qualifies for emergency power but does not qualify for the multiplier of 5, as the alternator/battery system constitutes a motor-driven generating system

(Class D) Home stations: Stations operating from permanent or licensed station locations using commercial power. Class D stations may work all Field Day stations again this year.

(Class E) Home stations - Emergency power: Same as Class D, but using emergency power for transmitters and receivers. Class E may work all Field Day stations.

I have made both pages of the Field Day Form into a fillable PDF.

Reports:

Activity: Confirmed Amazon Web fees. Modified Club owned equipment list to better reflect the current state of the equipment.

Craig WR2GNoel NO2EL is adding packet equipment to the IC-288 loaner moved that the Treasurers report be accepted. Carl WA2YCI Seconded. The Treasurer's report was accepted.

Old Business:

Noel NO2EL is adding packet equipment to the IC-288 loaner. Chris W3CJD reported that ARES is moving to Winlink.

Chris also reported a GRMS repeater on 462.575 PL 123 in Lake Hopatcong that is available for emergency use.

Noel and Harvey WS2Q explained GRMS licensing and repeater coverage in the area.

New Business:

Chris announced the ARES training to be held on 5/17 on 146.895

A combined ARES Races exercise is being planned for the fall.

A Field Day discussion was held. We will be planning on doing an in person event at the park. The exact format will depend on the COVID restrictions in effect at the time.

Chris W3CJD will handle the traffic and Section Manager Message instead of Craig. Noel will check out the satellite setup. Noel checked out the park and says that everything looks good.

Pat K2SCH moved that the meeting be closed. Chris W2CJD Seconded

If anyone wants a copy email me at WA2VQF@ ARRL.net and I'll send it to you.

Don't forget the bonus points. Emergency Power, Section Manager Message, W1AW Field Day Message, Satellite QSO's, Submitted via the web app. All of these will be available to home stations for points.

Lastly Logging. If you want to you can hand log but, the logging program we use on Field Day N1MM Logger + is free. You can download it from here:

https://n1mmwp.hamdocs.com/downloads/n1mm-full-install/

Even if you don't have it talking to your rig you can still use it to log your contacts. Just remember to set it to the band that you are on.

Your submission does not require a log but it does require dupe sheets as proof. N1MM does not produce a dupe sheet so I generate them a different way but, the ARRL will accept a Cabrillo format log file as proof and N1MM will generate that.

Remember that Field Day is not just for the low bands. The VHF bands are also fair game and 6 Meters has been very active lately especially using FT8. Most of the newer low band rigs also cover six. You just can't use a repeater.

So make sure that you have "MORRIS RADIO CLUB / HANOVER TWP OEM" in line 2 of the Field Day Form. I already have it in the PDF version.

You can also submit your entry online. Doing so gets you 50 bonus points. You need all the same information as the regular Field Day Entry Form. You can also upload your required documentation directly at this site:
